Today begins reenrollment for our current school families. All of the information needed for this process is attached as a file. - ✓ New Science materials will be purchased for all grades. (*This year we were able to adopt a new English Grammar and Writing series for all grades.*)
- ✓ Growing technology within the school will continue to be a priority. A long range plan is being identified so that we make good use of the materials currently in the school, and make fiscally sound future purchases. (*This year we were able to add another portable cart with netbooks, a set of netbooks dedicated to the Gifted/Talented classes, and document readers for every teacher requesting one.*)
- ✓ Add an additional part-time curriculum support person (Mrs. Howard is here on Wed. & Thurs. and we hope to have someone to cover the additional days). (*This year we added Mrs. Gitzinger as our full time Gifted/Talented teacher and Coach Persinger as our full time PE Aid.*)
- ✓ Provide additional incentives for teachers already holding a Masters Degree, and encourage further professional development for all faculty members.

I am committed to maintaining All Saints Catholic School as your school of choice.

ALL SAINTS CATHOLIC SCHOOL Reenrollment and New Student Timeline 2012-2013

- January 6, 2012** Reenrollment forms are emailed to families
- January 27, 2012** **\$425** of the **\$850 per child tuition deposit** due with the signed Enrollment and Tuition Agreement to secure child's spot for 2012-2013. In order to maintain current priority enrollment it is important this enrollment deadline is met. Your reenrollment is not guaranteed beyond this date if the deposit and agreement are not returned by January 27, 2012.
- March 2, 2012** New student acceptance letters mailed
- March 9, 2012** New student tuition deposit due \$850 per child
- April 1, 2012** Financial Aid applications due. Limited financial aid is available. Financial aid applications completed online at www.factstuitionaid.com. Financial aid applications must be completed each year.
- April 16, 2012**
- Returning Families:**
- Balance of tuition deposit due, \$425 per re-enrolling child. **\$50 late fee** will be applied if tuition deposit is not completed by this date
 - Families currently enrolled in **FACTS**, will automatically be reenrolled in **FACTS** unless the school is notified and tuition paid in full. Contact Laura Olson for any changes to account information.
 - Families not previously enrolled in **FACTS**, enrollment in **FACTS** completed online through link on the school website www.allsaintsk8.org

- Completed **FACTS** enrollment on line through link on school website www.allsaintsk8.org if not paying the tuition in full.
- April 16, 2012** Tuition payment in full due (cash or check only) in order to receive **\$100 per child discount** (discount applies to each tuition paid in full)
- May 25, 2012** Tuition payment in full (no discount) for families not enrolled in FACTS.
- June/July 5 or 20, 2012** Begin drafts of 2012-2013 tuition payment via FACTS, two, ten, or eleven month draft plan, automatic tuition withdrawal.

ADMISSION REQUIREMENTS

As a Catholic, parochial school dedicated to academic excellence with a disciplined, value-centered environment, All Saints Catholic School actively seeks partnering families and students who have demonstrated a positive attitude toward the value of Catholic education. In order for your registration or reenrollment to be accepted by All Saints Catholic School, a review of the following requirements will be performed:

1. Financial Requirements:
 - Application Fee paid for new students
 - Payment of the tuition deposit for each student
 - Current with 2011-2012 tuition and fees (if reenrolling)
 - Minimum \$600 per year contribution to the Parish for 2012 to receive parishioner tuition rate.
 - Current on the required capital campaign pledge of \$3,000 or pledge card completed for new families. The pledge to be paid within three years of original acceptance to All Saints. The level of contribution in any future capital campaigns will be determined by the individual.
2. Other
 - Comply with all age and immunization requirements of the State of Texas
 - Meet requirement of Texas Catholic Conference, as well as all the requirements of the Catholic Diocese of Dallas
 - Volunteer hours have been met (a minimum of 20 hours should be completed by 1/3/11) for returning families

TUITION PAYMENT OPTIONS

1. Full Payment

- Full cash/check payment due on or before April 16, 2012 to receive a **\$100 per child tuition discount**.
- Full cash/check payment on or before May 25, 2012 (no discount).

2. FACTS Payment Options (register via link on the school website www.allsaintsk8.org)

- Bank draft for 10 months beginning July 2012 (5th or 20th of each month), or 11 months beginning June 2012 (5th or 20th of each month). Registration with FACTS is required by May 1, 2012. FACTS will charge a yearly \$41 nonrefundable processing fee. There is no draft fee assessed by the school.
- Bank draft for 2 semi-annual payments in July and December 2012 (5th or 20th of the month). Registration with FACTS is required by May 1, 2012. FACTS will charge a \$15 processing fee. There is no draft fee assessed by the school.

TUITION AND FEES COMMITMENT

All tuition, deposits and fees are non-refundable. Upon receipt of signed Enrollment and Tuition Agreement Form, and the tuition deposit, **families are responsible for the full year's tuition and fees** regardless of tuition payment option and/or subsequent withdrawal of their child(ren) from the school.

ADDITIONAL FEES

Additional fees include:

- Supply Fee (per child)
- Class Dues (per child)
- Band/Orchestra Fees (5th-8th if applicable)
- Athletic Team Fees (5th -8th if applicable)
- Home and School Dues (per family)
- Any Applicable Elective Fees (Middle School, if applicable)

The fees (except Athletic Fees) are paid in May at Fiesta of Forms on May 10, 2012. Athletic fees are paid before each DPL team season (for example, Volleyball in August, Basketball in November, Track and Field in spring, etc.) and only by participating students.

FINANCIAL AID

Limited financial aid is available to qualified families. All applications are submitted online at www.factstuitionaid.com and must be completed by April 1st to be considered for all possible scholarships. Families must complete a new application each year to be considered for financial aid.

In consideration of the acceptance of this agreement by All Saints Catholic School, the undersigned agrees to pay the required fees as set forth in the 2012-2013 Tuition and Fee Schedule.

Enrollment is for the entire school year only, or such portion as may remain after entrance date. All tuition deposits must be paid in full on or before April 16, 2012. After that date, any unpaid deposit is considered a voluntary withdrawal of the student by his parent, and the School will proceed to admit and enroll a student in his place.

By signing this agreement, student and parents agree to abide by all rules, regulations, and directives of the School. No refunds will be made for absences, suspension, withdrawal, or dismissal. Any deposits or payments on tuition which are retained by the School hereunder are agreed upon as liquidated damages and shall be for the purpose of reimbursing the School for the damages which the School presently expects to incur in connection with the undersigned's failure to perform this agreement or for absences, suspension, withdrawal, or dismissal. The actual damages to the School as a result of any such events will be difficult to ascertain precisely, and, accordingly, the retention of said deposits or payments on tuition constitutes a reasonable and good faith estimate of the extent of such damages.

PLEASE NOTE* All Tuition and Fees are non-refundable. Upon payment of the tuition deposit, families will be responsible for the FULL year's tuition and fees regardless of tuition payment option and/or subsequent withdrawal of the child/ren from the school.**
